Please carefully read the following conditions as they form the basis for acceptance of all bookings.

**PRICES**

All prices are based on tariffs and exchange rates at the time of printing and may be changed without notice, until final payment is received. An exception is if a Government tax is increased or introduced.

**ALTERATIONS TO TRAVEL ARRANGEMENTS**

Arrangements are made in what the operator - PAINTCHINATOURS considers to be in your best interest. However, the right is retained to modify or cancel any excursion or accommodation facility if it cannot be provided for any reason. In such an unlikely event, PAINTCHINATOURS will offer alternative arrangements.

**TRAVEL INSURANCE**

Comprehensive travel insurance is a compulsory condition of acceptance as a participant of the tour. It is your responsibility to obtain suitable travel insurance coverage (of your choice) prior to joining the tour. All participants must complete the personal health statement on the booking form. This is for your own security and in case of emergency medical care during the tour.

**MOBILE TELEPHONES**

As a matter of courtesy, tour members are requested not to use mobile phones whilst on the touring coach, nor in restaurants or situations which interfere with the normal operation and comfort of other passengers on the tour.

**RESPONSIBILITIES**

PAINTCHINATOURS (hereinafter referred to as the operators) and/or their associated companies or agents, act only in the capacity of agents for the passenger in all matters of transportation, tour operation and other services. All receipts, tickets, vouchers, coupons or exchange orders are issued subject to the terms and conditions under which transportation and other services are provided.

The operators and/or their associated companies or agents assume no responsibility for loss, injury, accident, delay, damage or irregularity that may be caused to person or property, however caused or arising during any tour under its management, sponsorship, procurement or otherwise. It is the responsibility of the passenger to make sure that he/she is in possession of the proper travel documents and that they are in compliance with current government and transportation companies' regulations.

The right is reserved to modify the itinerary in any way considered necessary or desirable, or to change any reservation, hotel feature and/or means of conveyance, without notice and for any reason whatsoever and without allowance or refund. The right to withdraw tour membership from anyone whose behaviour is likely to affect the smooth operations of the tour or adversely affect the enjoyment and safety of other passengers is reserved and neither PAINTCHINATOURS nor the operators shall be under any liability to such person whatsoever. The right is also reserved to cancel or withdraw any tour, or any booking made for a passenger, or to decline to accept any person as a member of a tour.

**COMPLAINTS**

If you have cause for complaint whilst on tour, you must immediately bring it to the attention of your tour host who will endeavour to rectify the situation. Should our representative/agent be unable to resolve the problem, details of the complaint should be notified in writing to PAINTCHINATOURS.COM within 30 days of completion of the tour.

**UNUSED SERVICES**

Kindly note that no refund for unused ground and flight content will be made for any reason. If you make any alteration to any portion of the holiday, such alteration will be completely at your expense. Refunds are not available for services provided in the holiday price, but not utilised by the passenger.

All tickets, deposit tickets, coupons or orders are furnished and issued subject in all respects to those terms and conditions under which the means of transportation or other services provided thereby are offered or supplied by owners, operators, public carriers, or managing agents.

The issuance and acceptance of receipts, tickets, vouchers, coupons, or exchange orders shall be deemed consent to the above conditions.
